MLAR President's Report: Indu Jaiswal

It is customary for MLAR to provide its membership with an annual report on the organization's operation during the last fiscal year as part of the annual Teacher Award Night Event. This year's Heritage Language Teachers Award Night takes place on May 7th, 2012, and I am pleased to mention below, what you will find in this year's copy of MLAR's Annual Report for 2011-2012. In the pages that follow, you will find details of the following:

After a review of the Annual Report documents of the past few years, it came to my attention that nothing was included in any of those documents about the important contribution that the Saskatchewan Multicultural Centre Association (SMCA) makes to the work of our organization. SMCA is a non-profit corporation that manages the property at 2144 Cornwall Street. The current SMCA Board consists of the following volunteers: Girma Sahlu (Secretary) and Raphael Hwang (Treasurer); Tony Harras (President) and Mary Kolitsas; Terry Zwarych and Mary Vogel (Vice President).

The SMCA Board is responsible for the management of the property at 2144 Cornwall Street. The Board has the authority to make the decisions required to ensure that enough revenue is generated from rent of office space, common areas and storage areas, from parking fees, and from use of a shared photocopier, so that all operating costs can be met. Operating costs include annual taxes, insurance, utilities (SaskPower, SaskEnergy, Water & Sewer, City of Regina), and yard maintenance (grass cutting, snow removal, etc) as well as janitorial services, site management fees, plus some occasional other operating expenses as these arise.

In addition to the above, the SMCA Board is also responsible for necessary repairs to the property. Over the last 4 years, some major repairs had to be undertaken, which included replacing the roof shingles and repairing of eaves troughs, major repairs to the foundation and basement, repairs to the floors (resurfacing the hardwood on the main floor; new carpets on stairwells, landings and most of the second floor), and more recently, major repairs to the roof of the front veranda and to the attached fire escape. The total cost of all of the above capital repair costs was \$ 84,558. Payment of these capital costs involved direct contributions from MLAR, SOHL and RMC, with SMCA covering the balance of the costs from rental revenues. MLAR's direct contribution was \$ 19,866; SOHL's direct contribution was \$ 19,866; RMC's direct contribution to date was \$ 11,866, and SMCA covered the balance of \$ 32,960.

As President, I would like to thank SMCA and MLAR Board Members and Committees for their dedicated work, and as well, a sincere thank you to all who contributed to a successful Heritage Language Program in Regina and area during the 2011-2012 school year.

Professional Development Committee (PDC) Report for 2012

The Professional Development Committee is responsible for planning in-service training for heritage language teachers in Regina and surrounding areas. The committee meets on a regular basis to plan workshops designed to meet the needs and concerns of heritage language teachers, to help them improve their teaching skills and to show them methods of second language instruction as practiced in regular Canadian schools.

During school year 2011-2012, one teacher in-service training workshop was offered to teachers. It was jointly sponsored by the Multilingual Association of Regina (MLAR) and the Saskatchewan Organization for Heritage Languages (SOHL).

The workshop which was held on November 19th, 2011 was on "Effective Teacher / Student Communication". It was facilitated by Sarah Scarff, a regular Regina Public School system teacher. Approximately 60 heritage language teachers attended this workshop. A review of the evaluation sheets that were turned in indicated that it was a well-organized and well-presented workshop, and that the many classroom teaching ideas and activities that were presented would help in the motivation of their students.

Presently the Professional Development Committee (PDC) is planning a workshop in November 2012 on a topic based on the suggestions offered in the evaluations of the November 2011 workshop. If anyone has additional suggestions for workshop topics, please e-mail those suggestions to the MLAR Office, mlar@accesscomm.ca for future considerations.

As co-chairs of MLAR's Professional Development Committee, we would like to take this opportunity to thank all the members of this Committee: Indu Jaiswal, Raphael Hwang, Ved Arora, Girma Sahlu and Maria Kotsetas. The committee's sincere thanks also goes out to MLAR's Office Coordinator Emile Carignan, for his tireless assistance in making our workshops a success.

Regina Multilingual School (RMS) Committee

The objective of the Regina Multilingual School Committee has been to promote and help heritage language schools by providing the following services:

- 1. Organize and conduct school visitations twice yearly with the help of volunteers;
- 2. Arrange a Principal's meeting, to discuss issues and to allocate classrooms;
- 3. Provide current information to members through quarterly MLAR newsletters;
- 4. Share information and programs with member schools electronically;
- 5. Provide information to the community through public media and schools;
- 6. Use electronic media to promote heritage language programs;
- 7. Recognize the contributions of heritage language teachers annually;
- 8. Provide assistance to new heritage language schools; and
- 9. Provide orientation to teachers for the use of school facilities.

The Committee assists member schools to have access to Public School facilities to teach their language programs. During the current school year, over thirty heritage language schools are conducting classes at various locations in the city, with the majority of them teaching at Balfour and Campbell Collegiates. During the current school year, three new schools were organized and provided language classes: the Nepali Bhasha Pathshala, Das Schulhaus, and Norwegian Schools. Two others have approached MLAR to start classes as soon as possible, for the Somali and for the Swahili languages.

The following activities were conducted by the RMS Committee during 2011-12 school year:

- 1. The annual principals' meeting was held on Monday August 29, 2011 at Travelodge Hotel, attended by more than 45 teachers and board members. The topics covered included policy for using school facilities, allocation of classrooms, funding issues, and communication.
- 2. The annual Award Night for 2011 was held on May 9 at the Travelodge Hotel. The following volunteers were the recipients of awards:
 - (1) The New Teacher Award to Yali Michelle Geng of Regina School of Chinese Studies;
 - (2) The Youth Teacher Award to Arnav Jatukaran of ICA Hindi School;
 - (3) An Honorary Teacher Award to Anita Mary Drebot of Ukrainian School. She has been teaching Ukrainian for more than thirty years.
 - (4) The Honorary Life Membership Award went to Sharon Yuzdepski for her contribution and dedication to the Heritage Language community of Saskatchewan.

This year school visitations were conducted by 6 volunteers (Indu, Raphael, Mary, Jim, Subrato and Emile) on behalf of SOHL and the Ministry of Education. Each school has been visited by the committee at least twice. The purpose of these visits have been to improve communication with our members and also provide them information on various activities of SOHL, SIA and MLAR

The Award Night for 2012 will be held on May 7 at Travelodge Hotel. We urge all our schools every new school year to start early to consider their dedicated volunteers for the above mentioned awards.

On behalf of the RMS committee, a sincere thank you to all MLAR board members, dedicated volunteers and to Emile Carignan, MLAR's Office Coordinator, for their cooperation and assistance.
